Payment terms and conditions

For product theatre sessions a deposit of 50% of the total fee is requested on application. After ECNP has received the application the company will be issued an invoice which must be paid according to the payment terms specified.

The invoice for the balance due will be e-mailed to companies in February 2019. The amount of the invoice is due within 15 days of invoice date. If full payment is not received in due time, the allocated time slot may be re-assigned and the deposit forfeited. Companies will not be allowed to hold the session unless the fee has been settled in full.

Companies participating in the organisation of product theatre sessions are required to observe all payment deadlines as stated in the Industry session guidelines and/or on the invoices. The 32nd ECNP Congress Foundation is entitled to cancel the participation of any company that fails to comply with these deadlines.

Dutch VAT will be charged in accordance with European legislation.

Cancellations

Cancellations of product theatre sessions must be sent in writing to the ECNP Office. The effective date of the cancellation will be the date that the written notification was received by the ECNP Office.

In the event of cancellation, the following policy will apply:

- 50% of the total amount will be refunded for cancellations made before 1 March 2019
- 30% of the total amount will be refunded for cancellations made on or after 1 March and until 1 May 2019
- No refund for cancellations or reduction made on or after 1 May 2019

Refunds will be made after the congress.

Disclaimer
