## Our audience



The Industry Satellite Symposium programme is Europe's primary platform for presenting new industry science to the European CNS research and clinical communities.

#### Sharing discoveries

#### Industry Mini Session (IMS)

These concentrated sessions offer an authoritative platform for new research and developments.

- 45 minutes scientifically oriented sessions
- Scheduled so as not to compete with scientific sessions - to give congress participants the maximum opportunity to attend
- Presented at the congress venue, livestreamed and available on-demand
- Featured in the ECNP app and on the ECNP Congress website

#### Engaging with clinicians

#### Industry Interactive Discussion (IID)

These interactive sessions offer the opportunity for more focused, scientifically driven engagement with participants.

#### Problem-solving with industry experts

#### Industry Case Study (ICS)

These interactive sessions provide participants with the opportunity to discuss the application of medicines, devices, and/ or treatment strategies in real-world clinical settings. After a 6-7 minute introduction, the session focuses on clinical best practice and interactive problem-solving.

- 30 minutes with 1 or 2 experts
- For around 80 participants
- Run in parallel with the official ECNP scientific programme
- Presented only at the congress venue and not livestreamed
