## **WELCOME**

The Research and Scholarship Foundation of ECNP is a 100% public interest serving entity established to promote research activity in the field of neuropsychopharmacology and to create a framework for the organisation of ECNP’s annual congress.

Today, the Research and Scholarship Foundation is the engine of ECNP’s scientific and educational programme, and the umbrella for its annual Junior Scientist Workshop, its clinical Schools in Oxford and Venice, and its Seminars. Together, these events bring together 300 junior scientists annually for education and training, the cost of which is entirely borne by the Foundation.

In addition, the Foundation supports ECNP’s core research activities, including programmes such as the Taskforce on Nomenclature, a collaborative initiative with ECNP’s international counterparts to rationalise the naming conventions of psychotropic drugs; and the highly successful ECNP Networks, with its associated Targeted Network Meetings, held for the first time in 2013 (4-5 October, Barcelona, Spain). It also promotes dialogue with Europe’s regulatory authorities, funding the ECNP Consultation meeting (10-11 March, Nice, France) to help the formulation of practicable and effective regulatory standards for drug use, as well as the Collaborative Forum (7 October 2013, Barcelona, Spain) to discuss strategies for progress in European CNS drug development.

Together, these activities – when combined with those of the Research and Scholarship Foundation’s sister entities – make the ECNP organisation the largest non-institutional supporter of research and education in applied and translational neuroscience in Europe.

## **ECNP Workshop 2013**



In 2013 from 7-10 March another ECNP Workshop took place in Nice, France. During this three-day workshop on neuropsychopharmacology junior scientists from Europe are brought together with research leaders to discuss the latest advances and perspectives on specific topics. By promoting and encouraging the development of junior scientists seeking to pursue research careers in neuropsychopharmacology, the ECNP Workshop aims to stimulate high quality experimental and clinical research in mental disorders and their treatments. The Workshop focuses on three recurring topics and one variable topic:

- Molecular neuropsychopharmacology
- Behavioural pharmacology
- Clinical neuropsychopharmacology
- Variable topic: Epigenetics: towards new drug targets

Within each topic two distinguished scientists addressed specific themes, after which there were short presentations by five junior scientists, who were invited to present their research.

For the 2013 Workshop 130 abstracts were submitted. 106 young scientists from 20 countries were invited to participate in the Workshop on the basis of their abstracts. For those selected no registration fee is charged and the travel and accommodation is substantially covered by the ECNP Research and Scholarship Foundation.

On Saturday afternoon two optional sessions were organised: one on “Getting funded”, presented by Cathy Fernandes (United Kingdom) and by Christof Kuhstoß (Germany). The other one was on “Jobs in industry versus academia”, presented by Jack Price (United Kingdom) and by Thomas Steckler (Belgium).

Sixteen junior scientists were invited to speak at the ECNP Congress held from 5-9 October 2013 in Barcelona, Spain.

Every year, we are pleasantly surprised by the passion and dedication of the participants that join us. This year was no exception. While the sun was shining, all rooms were packed with participants eager to learn. It was great to see that there were again a number of participants from our ECNP Ambassador countries and we hope that this number will only increase in the coming years.

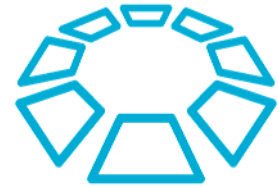

## Consultation Meeting 2013

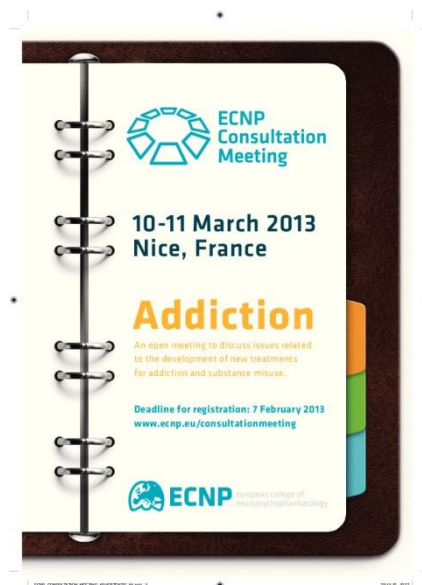
ECNP takes an active role in liaising with Europe’s regulatory authorities to help in the formulation of practicable and effective regulatory standards for drug development. The ECNP Consultation Meetings have become a highly respected forum for the discussion of clinical trial guidelines.



From 10-11 March 2013 a meeting was organised in Nice, France with the overall subject: “Addiction” and with topics:

- Burden and cost of addiction
- Regulatory perspectives
- Harm reduction
- Agonist and antagonist treatments
- Cannabis dependence

44 participants from 19 European and non-European countries took part in the discussions.



## **ECNP School of Neuropsychopharmacology**

In 2013 the 4th ECNP School of Neuropsychopharmacology was held in Oxford, United Kingdom, run by Guy Goodwin. The ECNP School of Neuropsychopharmacology offers a select number of participants a week-long programme of intensive training in all aspects of neuropsychopharmacology: from its fundamentals to the use of medications in individual indications, good clinical practice and optimal treatment and algorithms. Participants are nominated by members of the ECNP Advisory Board of National Societies or ECNP Ambassadors, with two to three potential candidates per country, on the basis of their career potential. A maximum of 50 young psychiatrists will be accepted and their travel and accommodation costs will be substantially covered by ECNP. The ECNP School of Neuropsychopharmacology is open to psychiatrists from across Europe who are within five years of having received their defining qualification.



49 psychiatrists from 23 countries were selected on their career potential of which the majority works at University Hospitals. A total of 15 top-scientists voluntarily devoted their time to teach and train participants and have in-depth discussions with them. A survey showed that the majority of the participants found the scientific and educational standard excellent and the information presented highly significant.

## **ECNP School of Old Age Neuropsychopharmacology**

Over the past 100 but notably the last 50 years the demographic pattern in Europe has changed radically, resulting in a large increase in the proportion of older people, many of whom live to an advanced age. This has led inevitably to an increase in the incidence and prevalence of mental disorders in this group of the population. Dementia is, of course, well known but affective and other disorders are also very common. In many European countries a relatively new speciality of old age psychiatry has developed, but knowledge and skill in treating mental disorders in older people is needed in all countries. Clearly, there are many social aspects to the management of old age mental disorders, but clinical care has to be based on a fundamental understanding of psychopathology, neurobiology and psychopharmacology.



ECNP has made education and training in neurobiology and neuropsychopharmacology a priority, therefore a School for Education in Geriatric Neuropsychopharmacology has been established. The aim is to encourage and disseminate excellence in clinical neurobiology and neuropsychopharmacology among psychiatrists who treat older people, the first school was held in Venice, Italy from 28 April to 3 May 2013.

The school was constructed as a five-day course borrowing from the experience with the Oxford ECNP School of Neuropsychopharmacology and Venice School on Child & Adolescent Neuropsychopharmacology.

The program included: 18 plenary lectures on the critical, evidence-based use of medication in psychiatric disorder with an onset in childhood and adolescence, 9 workshops in which a member of the faculty discussed with a small group of participants complex clinical cases or specific hot topics presented during the plenary lectures, 1 debate on the role of medications as first line treatment in Child & Adolescent Psychiatry and 1 practical plenary session on how to prepare an effective presentation.

Feedbacks were overwhelmingly positive: participants reported the possibility to interact with faculty during the presentations and the workshops as a very inspiring learning experience. Everyone also enjoyed the relaxed and lively atmosphere and the enthusiastic attitude of the other participants, leading not only to improve their professional knowledge but also to gain new friends. ## **ECNP SEMINARS**

The aim of the ECNP Seminar is to provide an interactive training course for future leading scientists in neuropsychopharmacology. Organised every time in a different Eastern European country, it offers junior participants the opportunity to enhance their knowledge and skills in a concentrated learning environment with local and international experts.

The Seminar is intended for those countries whose junior researchers and practitioners have limited opportunities to attend international meetings.

Around 50 participants attend, selected on the basis of their curriculum vitae and a short abstract (50-100 words describing research or a case). Outstanding participants of the Seminar (max. 5) are awarded free registration and a subsidy towards travel cost for the succeeding ECNP Congress on the condition that they submit an abstract for poster presentation and that the abstract is accepted.

In 2013 two ECNP Seminars were organised: 16-18 April 2013, Suzdal, Russia and 15-17 May 2013, Baltezers, Latvia. ECNP covered all costs. The participants only had to pay their own travel costs.

### **ECNP Seminar Suzdal, Russia**

49 participants were selected on the basis of their CV and a short abstract.

The participants were very content with the scientific and educational level of the sessions.

They found the information presented highly relevant to their clinical practise. Two additional talks were given by Celso Arango on “how to give a talk” and “how to prepare a scientific paper”. The participants found these session very helpful. On Saturday afternoon and Sunday morning the participants were split in three working groups. These workshops, organised with the assistance of three local experts, Sergey Mosolov, Margarita Morozova, Elena Kostioukova, were very interactive.

Furthermore the ECNP Seminar was an excellent opportunity to meet with top scientists and other colleagues in the field.

Three participants received a Seminar Award, which included free registration and a subsidy towards travel cost for the ECNP Congress which was held in Barcelona, October 2013. The winners were Olga Karpenko, Shmeleva Liubov and Daria Smirnova.



### **ECNP Seminar Baltezers, Latvia**

35 participants were selected on the basis of their CV and a short abstract from the countries around Latvia. Four came from Estonia, eleven from Latvia, fifteen from Lithuania and five from Belarus.

The participants really enjoyed the seminar and the combination of scientific sessions, highly educational workshops and plenty of time for interaction. Two additional talks were given by Celso Arango on “how to give a talk” and “how to prepare a scientific paper”. The participants found these session very helpful. On Thursday afternoon and Friday morning the participants were split in three working groups. These workshops, organised with the assistance of three local experts, Elmārs Rancāns (Latvia), Robertas Bunevicius (Lithuania), Jaanus Harro (Estonia) were very interactive.

## **Mini-symposia**

In 2013 two mini-symposia were organised. They facilitate the diffusion of cutting-edge research and clinical practice in a simple, easy-to-organise, low-cost and high-impact format. It is an easy way to increase awareness of ECNP's activities and to ensure that local researchers are fully informed about the scientific and educational opportunities ECNP has to offer.

The mini-symposium will typically consist of three scientific talks, plus a short introduction to ECNP. Three speakers will be invited: one ECNP representative who will also present the introductory talk, one ECNP expert, and one local speaker. After the symposium there is the opportunity for the participants to interact with the speakers while enjoying a drink.

ECNP pays the travel and hotel costs of the two non-local speakers. ECNP also covers the costs of the meeting room, audio visual equipment and the refreshments.

### **ECNP Mini-symposium at the XII Conference of College Private Psychiatry, 22 March 2013, Sofia, Bulgaria**

The UFO Club of young Bulgarian researchers in neurosciences unites associated members of ECNP. Before the 12<sup>th</sup> Conference of College Private Psychiatry, they coordinated an ECNP Mini-Symposium and the main talks were given by Joseph Zohar, Israel (“Impulsive and compulsive features in OCD and addiction”) and by Naomi Fineberg, United Kingdom (“Obsessive-compulsive spectrum disorders and impulse control: a trans-diagnostic perspective”). The audience comprised 97 Bulgarian psychiatrists and psychologists who engaged the experts in a vivid discussion. After the symposium both ECNP experts had a meeting with the members of the UFO Club and elaborated at length on impulsivity, compulsivity, OCD spectrum and other topics of interest for the young investigators. It was a warm, open and honest exchange of opinion and first-hand learning from the vast experience of professors Zohar and Fineberg.

The ECNP Mini-Symposium turned out to really be the highlight of the conference. It led to a prolonged discussion among the participants in the event and also received extensive media coverage. This educational and scientific activity was the most recently added link in the long chain of events giving proof of the very fruitful long-standing contacts between ECNP and Bulgarian psychiatric community.

### **ECNP Mini-symposium, 5 April 2013, Warsaw, Poland**

The Institute of Psychiatry and Neurology in Warsaw hosted the ECNP Mini-Symposium that brought together ECNP President Joseph Zohar, ECNP Ambassadors from Georgia and Portugal, psychiatrist and scientists working at the Medical University and Institute of Psychiatry and Neurology in Warsaw.

The ECNP-Mini Symposium took place at the main lecture hall the Institute. There were three presentations:

1. Revolution in anxiety disorders – the background and clinical implications of the upcoming changes in DSM 5 diagnosis of anxiety disorders.

2. Classification of schizophrenia and schizophreniform disorder - current problems and solutions.

Przemysław Bieńkowski, Department of Pharmacology, Institute of Psychiatry and Neurology, Poland

After each lecture there was time for short discussion. The symposium finished with coffee break for participants and a “hospital tour” for guest from ECNP that was guided by the local coordinator Adam Wichniak.

## Supported talks

In 2013 five supported talks were organised. The general goal of the ECNP supported talk is to facilitate the diffusion of cutting-edge research and clinical practice in a simple, easy-to-organise and high-impact format. The talks will ensure that researchers/scientists at other meetings/congresses are fully informed about the scientific and educational opportunities ECNP has to offer. The talk is a plenary lecture at a nationally organised meeting by a member of ECNP at a prime-time slot. The lecture is preceded by a short introduction talk on ECNP by the chair of the session. ECNP supports the travel costs, including air fare (economy class), hotel accommodation and public transport, up to a fixed amount, depending on the travel distance of the speaker.

## **ECNP Networks**

The ECNP Networks were launched in 2007 to address a critical and widely recognised shortcoming in Europe’s neuropsychopharmacological research infrastructure: the lack of a common database accessible to European researchers for conducting studies into the main psychiatric conditions. The cooperation that the networks have fostered at the scientific, technical and clinical level has already yielded significant research and public health dividends.



The aims of the ECNP Networks are to:

- Foster multicentre European collaboration in order to collect in a standardised way the essential clinical, psychological, biological and therapeutics variables to be analysed in clinical studies and pharmacological trials.
- Create and foster European networks of highly qualified investigators.
- Provide a platform for collaboration on the development of common assessments and new or follow-up projects

In 2013 eight ECNP Networks with highly qualified investigators were active:

- Anxiety Disorders Network (ADRN)
- Bipolar Disorders Network (ENBREC)
- Child and Adolescent Neuropsychopharmacology Network
- European Network for Schizophrenia (EGRIS)
- Experimental Medicines Network
- Neuroimaging Network
- Obsessive Compulsive and Related Disorders Network (OCRN)
- Suicide Network

The ECNP Network Board comprises of a chair (Celso Arango, Spain) and a scientific coordinator (Nic van der Wee, the Netherlands). The ECNP Taskforce is formed by the board and 2 members per network and they meet annually.

The aims of the Taskforce are to:

- Facilitate the development of new proposals through the experience of existing networks and the chairman.
- Facilitate interaction between networks.
- Monitor progress and appropriate use of funding.

In 2013 the Network Board met by teleconferences about twice a month. A Network Taskforce meeting was organised in Leiden, The Netherlands on 8 February.

Nic van der Wee, the scientific coordinator set-up individual meetings with all the chairs and co-chairs of the networks during the 26<sup>th</sup> ECNP Congress in October 2013 in Barcelona, Spain.

## **European Brain Council**



The College was instrumental in founding the European Brain Council, Europe’s leading policy advocacy organisation for the science and treatment of disorders of the brain, and continues to be an active member and supporter. In 2013 former ECNP president, David Nutt, was elected president of the European Brain Council. ECNP is working closely with the Council to support its Year of the Brain 2014 project.

## Nomenclature

For many years, there has been dissatisfaction with the nomenclature widely employed to classify the medicines used in the treatment of psychiatric disorder. To address this, ECNP established the Taskforce on Nomenclature, a collaborative initiative with the College's sister organisations: the American College of Neuropsychopharmacology (ACNP), the Asian College of Neuropsychopharmacology (AsCNP), the International College of Neuropsychopharmacology (CINP), and the International Union of Basic and Clinical Pharmacology (IUPHAR).



Drawing upon expert input from colleagues across the field, the Taskforce has defined new pharmacologically based principles for categorising the most frequently used psychotropic drugs. It is using these principles to develop a multi-axial system that acknowledges the pharmacological complexity of drugs and emphasises what they do at molecular, cellular and systems levels, while also recognising their clinical actions and adverse effects. The project endeavours to reframe all the 150 drugs that are currently in common clinical practice in psychiatry throughout the world.



The advantages for clinicians, patients, researchers, regulators and industry are significant, providing a logical and familiar framework for how to group different medicines, whatever their multi-axial complexity. The hope is that this new system, by being more rationally aligned with the disorders being addressed, will lead to better adherence amongst patients and more informed treatment choices among clinicians.



A meeting of the taskforce in San Francisco on 17 May 2013 produced the first draft, which was presented in an Educational Update Session at the 26<sup>th</sup> ECNP Congress in Barcelona. To help push the project into its implementation phase, Sue Wilson, a senior research fellow at Imperial College London, has been engaged as taskforce co-ordinator. Plans are underway to publish the first edition of the new nomenclature template in 2014.
